### DESCRIPTION OF LEVELS

#### Levels One & Two

These levels include: All non-swimmers; Any child (3-4 years or older) that cannot put their face in the water for at least three seconds.

#### Level Three

Participant must already be able to put their head in water for at least three seconds, and be able to swim front stroke and backstroke for five yards.

#### Level Four

Participant must already be able to front crawl with breathing and do back crawl for at least ten yards.

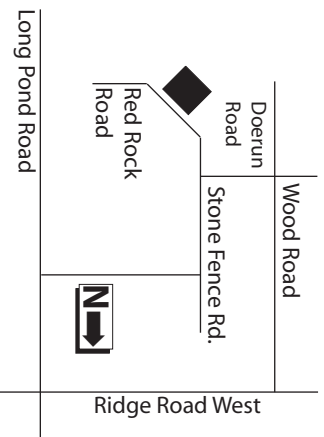
